

## Hamilton International Airport 2011/2012 "U in FUN" Twitter Contest

### Official Contest Rules

NO PURCHASE REQUIRED TO ENTER OR WIN

1. **ELIGIBILITY:** To be eligible for the contest, an individual must:
  - a) be a legal resident of Canada;
  - b) be at the age of majority (18 years old), or under the age of majority (18 years old) provided parental and/or guardian consent
  - c) follow @flyyhm on Twitter, and include the hashtag #UinFUN in their tweet to @flyyhm
  - d) not have won with any other Hamilton International Airport contests in the past 30 days

Hamilton International Airport has the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to Hamilton International Airport for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsor reserves the right, in its sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading information.

2. **CONTEST PERIOD:** Contest starts at 12:00:00 a.m. Eastern Time ("ET") on 2 January 2012 and closes on 11 March 2012 at 11:59:59 p.m. ET (the "Contest Period").
3. **HOW TO ENTER:** You may enter by tweeting @flyyhm on how you put the U in Fun on your last holiday; all tweets must be to @flyyhm and include the hashtag #UinFUN. There is no limit to entries per person. Individuals of any age may enter, parental or guardian consent must be provided for entries from individuals 18 years and younger. Any use of agencies or robotic, automatic, programmed, or similar entry methods will void all entries by that entrant. Any entries including photos become the property of Hamilton International Airport Limited and will be used at Hamilton International Airport's discretion.
4. **PRIZE DRAWING / ODDS:** The drawing of prize winners will be conducted in accordance with these Official Contest Rules, every two weeks after the initial start of the contest. The selection of winners will be conducted among all eligible entries received during the two week period and the selection of the winner is final and binding. The odds of winning the prize offered will depend upon the total number of eligible entries received.
5. **GRAND PRIZES:** There is a maximum of five (5) Grand Prizes, each of an approximate retail value of CDN \$100. Winner must redeem the prize within 5 business days of being contacted. If winner is unable to redeem the package within the time period required, the prize will be forfeited. Restrictions, conditions and limitations may apply. Hamilton International Airport reserves its right in its sole discretion to disqualify any individual they find to be tampering with the entry process or the operation of the Contest or to be acting in violation of the Official Contest Rules or otherwise in a disruptive manner. Any attempts to deliberately damage the website or social network, or to undermine the operation of this Contest is a violation of criminal and civil laws and should such an attempt be made Hamilton International Airport reserves its right to seek remedies and damages to the fullest extent of the law.
